LB 751 requires the Nebraska State Patrol (NSP) to conduct a study on how to increase protective and investigative resources for reporting, identifying, and investigating missing Black women and children in Nebraska.

NSP must work with the Commission on African American Affairs to convene meetings with law enforcement, federal partners, and urban community organizations to assess the scope of the issue, identify barriers, and develop partnerships. The bill also directs coordination with the U.S. Department of Justice to improve information sharing and resource coordination.

By June 1, 2027, NSP must submit an electronic report to the Executive Board of the Legislative Council containing data and analysis, identified barriers, and recommendations, including any proposed legislation. NSP states the agency will have a one-time cost of \$23,000, which may be able to be paid by federal funds if such funds are identified.

The Commission on African American Affairs states that LB 751 has no fiscal impact. The Commission on African American Affairs further states that if any costs result from implementing LB 751, the Commission will absorb those costs within existing resources.

Explanation of Estimate:

LB 751 requires a report to be prepared on missing Black women and children in Nebraska. This report is to be based on a study conducted by the Nebraska State Patrol to determine how to increase state criminal justice protective and investigative resources for reporting and identifying missing Black women and children. The State Patrol shall work with the Commission on African American Affairs to hold meetings with state and local law enforcement partners, federal agencies, and urban community organizations. Additionally, the State Patrol shall work with the United States Department of Justice to increase information sharing and resource coordination.

A report is required to be submitted electronically to the Executive Board of the Legislative Council by June 1, 2027, on the results of such study. The State Patrol estimates that there will be travel/board & lodging costs related to holding meetings in various locations in the state (\$350 x 4). Additionally, it estimates the need to rent facilities to hold such meetings with local law enforcement, the community, and federal agencies (\$400 x 4 = \$1,600). Consultants to provide data mining and compilation of statistics may be needed as well to prepare the study and associated report (\$20,000). The Patrol estimates these operational costs to total \$23,000. The Patrol will explore the possibility of obtaining federal grant funds if possible. However, there has been no funding opportunity identified at this time, and no funds awarded to date for this study.
