AM2682 strikes the original sections of LB784.

AM2682 amends provisions relating to county sheriffs and law enforcement training. The amendment would allow sheriffs in counties that do not contain a city of the metropolitan, primary, or first class to reside in the county or an adjoining county while in office, and would permit an appointed county sheriff to serve more than one county under section 23-1701. The amendment would revise sheriff uniform provisions by giving sheriffs discretion over uniform classes and specifications, while requiring uniforms to remain distinguishable from those of other Nebraska law enforcement agencies.

AM2682 would also revise continuing education requirements for law enforcement officers by requiring 24 annual hours for agencies with fewer than 25 full-time officers and 32 annual hours for agencies with 25 or more full-time officers, and by restructuring the required training subjects. The continuing-education changes would become operative on January 1, 2027.

There is no fiscal impact.
