- 1 A BILL FOR AN ACT relating to insurance; to amend section 44-211, Reissue
- 2 Revised Statutes of Nebraska; to change provisions relating to
- 3 qualifications and requirements for the board of directors of an
- 4 insurance corporation; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

- **Section 1.** Section 44-211, Reissue Revised Statutes of Nebraska, is
- 2 amended to read:
- 3 44-211 (1) The business and affairs of an insurance corporation
- 4 shall be managed by the incorporators until the first meeting of
- 5 shareholders or members and then and thereafter by a board of directors
- 6 elected by the shareholders or members and as otherwise provided by law.
- 7 (2)(a)(i) The board of directors shall consist of not less than five
- 8 persons, and, except as provided in subdivision (a)(ii) of this
- 9 <u>subsection</u>, one of them shall be a resident of the State of Nebraska.
- 10 (ii) Subdivision (a)(i) of this subsection shall not apply for a
- 11 period of five years upon the filing of an affidavit with the department.
- 12 Such affidavit shall be executed by the president or chairperson of the
- 13 board of directors of such insurance corporation and affirm that the
- 14 <u>insurance corporation meets the following criteria:</u>
- 15 (A) The insurance corporation's principal corporate executive
- 16 offices are located within the State of Nebraska;
- 17 (B) The insurance corporation is a publicly traded corporation on a
- 18 federally governed stock exchange or is a wholly owned affiliate of such
- 19 a publicly traded corporation;
- 20 (C) The insurance corporation has been domiciled in the State of
- 21 Nebraska for at least twenty-five years;
- 22 (D) The insurance corporation employs more than five hundred
- 23 employees who are employed in Nebraska and subject to the Nebraska income
- 24 tax on compensation received from the insurance corporation; and
- 25 (E) The ultimate controlling entity of the insurance corporation, as
- 26 <u>defined by the department, has not changed in ten years.</u>
- 27 <u>(iii) The affidavit described in this subsection may be filed by an</u>
- 28 insurance corporation any time after the criteria listed in subdivision
- 29 (a)(ii) of this subsection are met by the insurance corporation. An
- 30 <u>insurance corporation may file a new affidavit upon the expiration of the</u>
- 31 <u>five-year period. If at any time during the five-year period the</u>

- 1 insurance corporation no longer complies with subdivision (a)(ii) of this
- 2 <u>subsection</u>, the insurance corporation shall (A) provide written notice to
- 3 the department that specifies the criteria with which the insurance
- 4 corporation no longer complies and (B) appoint a member of the board of
- 5 <u>directors of the insurance corporation who is a resident of the State of</u>
- 6 Nebraska in accordance with subdivision (a)(i) of this subsection within
- 7 six calendar months after the criteria are no longer met.
- 8 <u>(iv) The affidavit described in this subsection shall be made before</u>
- 9 <u>an officer authorized to administer oaths under the laws of this state or</u>
- 10 under the laws of the state where execution occurs. Such execution shall
- 11 <u>be evidenced by the officer's certificate under official seal and shall</u>
- 12 <u>substantially be in the form found in this subdivision.</u>

- 17 of Nebraska, hereby declare that insurance corporation is an
- 18 insurance corporation that complies with all of the criteria in section
- 19 44-211 of the Statutes of Nebraska for waiver of the statutory
- 20 requirement that at least one member of the insurance corporation's board
- 21 of directors shall be a resident of the State of Nebraska. I further
- 22 declare that if at any time during the five-year period allowed under
- 23 section 44-211 the insurance corporation fails to comply with
- 24 <u>all of the criteria in section 44-211, the insurance corpora</u>tion will
- 25 notify the Department of Insurance of such failure and will work to
- 26 appoint a member of the board of directors who is a resident of the State
- 27 <u>of Nebraska as required by section 44-211 within six months after such</u>
- 28 <u>failure</u>.

- 4 (b) At least one-fifth of the directors of an insurance company,
- 5 which is not subject to section 44-2135, shall be persons who are not
- 6 officers or employees of such company.
- 7 (c) A person convicted of a felony shall may not be a director. T
- 8 (d) All and all directors shall be of good moral character and known
- 9 professional, administrative, or business ability that includes , such
- 10 business ability to include a practical knowledge of insurance, finance,
- 11 or investment.
- 12 (e) If the company is a mutual company or assessment association, no
- 13 No person shall hold the office of director unless he or she is a
- 14 policyholder , if the company is a mutual company or assessment
- 15 association.
- 16 (3) Unless otherwise provided in the articles of incorporation, the
- 17 board of directors shall make all bylaws. A director shall discharge his
- or her duties as a director in accordance with section 21-2,102.
