- 1 A BILL FOR AN ACT relating to public health and welfare; to adopt the
- 2 Stand With Women Act; and to provide for severability.
- 3 Be it enacted by the people of the State of Nebraska,

1 **Section 1.** Sections 1 to 7 of this act shall be known and may be
2 cited as the Stand With Women Act.

3 **Sec. 2.** The Legislature finds and declares that:

4 (1) Males and females possess unique and immutable differences that
5 manifest prior to birth and increase as they age and experience puberty;

6 (2) Differences between the sexes are enduring and may, in some
7 circumstances, warrant the creation of separate social, educational,
8 athletic, or other spaces in order to ensure safety and to allow members
9 of each sex to succeed and thrive;

10 (3) Physical differences between males and females have long made
11 separate and sex-specific sports teams important so that female athletes
12 can have equal opportunities to compete in sports while reducing the risk
13 of physical injury;

14 (4) Physical advantages for males relevant to sports include, on
15 average, a larger body size with more skeletal muscle mass, a lower
16 percentage of body fat, and a greater maximal delivery of anaerobic and
17 aerobic energy;

18 (5) Even at young ages, males typically score higher than females on
19 cardiovascular endurance, muscular strength, muscular endurance, and
20 speed and agility. These differences become more pronounced during and
21 after puberty as males produce higher levels of testosterone. On average,
22 male athletes are bigger, faster, stronger, and more physically powerful
23 than their female counterparts. This results in a significant sports
24 performance gap between the sexes;

25 (6) Testosterone provides benefits in relation to athletic
26 performance;

27 (7) Studies have shown that the benefits that natural testosterone
28 provides to male athletes are not significantly diminished through the
29 use of testosterone suppression. Testosterone suppression in males does
30 not result in a level playing field between male and female athletes; and

31 (8) Because of the physical differences between males and females,

1 having separate athletic teams based on the sex of the athlete reduces
2 the chance of injury to female athletes, promotes equality between the
3 sexes, provides opportunities for female athletes to compete against
4 their female peers rather than against male athletes, and allows female
5 athletes to compete on a fair playing field for scholarships and other
6 athletic accomplishments.

7 **Sec. 3.** For purposes of the Stand With Women Act:

8 (1) Athletic association means a corporation, association, or
9 organization which has as one of its primary purposes the sponsoring or
10 administration of extracurricular interscholastic athletic contests or
11 competitions;

12 (2) Boy means an adolescent human male;

13 (3) Female means an individual who naturally has, had, will have, or
14 would have, but for a congenital anomaly or intentional or unintentional
15 disruption, the reproductive system that at some point produces,
16 transports, and utilizes eggs for fertilization. Female includes a woman
17 and a girl;

18 (4) Girl means an adolescent human female;

19 (5) Male means an individual who naturally has, had, will have, or
20 would have, but for a congenital anomaly or intentional or unintentional
21 disruption, the reproductive system that at some point produces,
22 transports, and utilizes sperm for fertilization. Male includes a man and
23 a boy;

24 (6) Man means an adult human male;

25 (7) Postsecondary educational institution means a university,
26 college, or community college located in Nebraska that is a member
27 institution of an accrediting body recognized by the United States
28 Department of Education;

29 (8) Private school means any private, denominational, or parochial
30 school offering instruction in elementary or high school grades;

31 (9) Public school means any public school offering instruction in

1 elementary or high school grades;

2 (10) Sex means an individual's sex, either male or female; and

3 (11) Woman means an adult human female.

4 **Sec. 4.** (1) For an interscholastic athletic team or sport sponsored
5 by a public school, a private school whose students or teams compete
6 against a public school in an interscholastic sport, or a private school
7 that is a member of an athletic association, the team or sport shall be
8 expressly designated as one of the following based on sex:

9 (a) Males, men, or boys;

10 (b) Females, women, or girls; or

11 (c) Coed or mixed.

12 (2)(a) For an interscholastic athletic team or sport sponsored by a
13 public school, a private school whose students or teams compete against a
14 public school in an interscholastic sport, or a private school that is a
15 member of an athletic association, a team or sport designated for
16 females, women, or girls shall not be open to a male student.

17 (b) For an interscholastic athletic team or sport sponsored by a
18 public school, a private school whose students or teams compete against a
19 public school in an interscholastic sport, or a private school that is a
20 member of an athletic association, a team or sport designated for males,
21 men, or boys shall not be open to a female student unless there is no
22 female team offered or available for such sport for such female student.

23 (3) For an interscholastic athletic team or sport sponsored by a
24 public postsecondary educational institution, a private postsecondary
25 educational institution whose students or teams compete against a public
26 postsecondary educational institution, or a private postsecondary
27 educational institution that is a member of an athletic association, the
28 team or sport shall be expressly designated as one of the following based
29 on sex:

30 (a) Males, men, or boys;

31 (b) Females, women, or girls; or

1 (c) Coed or mixed.

2 (4)(a) For an interscholastic athletic team or sport sponsored by a
3 public postsecondary educational institution, a private postsecondary
4 educational institution whose students or teams compete against a public
5 postsecondary educational institution, or a private postsecondary
6 educational institution that is a member of an athletic association, a
7 team or sport designated for females, women, or girls shall not be open
8 to a male student.

9 (b) For an interscholastic athletic team or sport sponsored by a
10 public postsecondary educational institution, a private postsecondary
11 educational institution whose students or teams compete against a public
12 postsecondary educational institution, or a private postsecondary
13 educational institution that is a member of an athletic association, a
14 team or sport designated for males, men, or boys shall not be open to a
15 female student unless there is no female team offered or available for
16 such sport for such female student.

17 (5) In order to participate in an interscholastic athletic team or
18 sport that is designated for males, men, or boys or designated for
19 female, women, or girls and that is sponsored by (a) a public school or a
20 public postsecondary educational institution or (b) a private school or a
21 private postsecondary educational institution subject to the Stand With
22 Women Act, a student shall provide to such school or postsecondary
23 educational institution confirmation of such student's sex on a document
24 signed by a doctor or signed under the authority of a doctor.

25 (6) Nothing in this section shall be construed to restrict the
26 eligibility of any student to participate in any interscholastic athletic
27 teams or sports designated as coed or mixed.

28 **Sec. 5.** A government entity, licensing or accrediting organization,
29 or athletic association shall not entertain a complaint, open an
30 investigation, or take any other adverse action against a public or
31 private school or a public or private postsecondary educational

1 institution for maintaining any separate interscholastic athletic team or
2 sport for female students.

3 **Sec. 6.** The governing body of each public school and public
4 postsecondary educational institution and each private school and private
5 postsecondary educational institution subject to the Stand With Women Act
6 shall adopt a policy implementing the Stand With Women Act. Such policy
7 shall include provisions regarding the conduct of visitors and the
8 public.

9 **Sec. 7.** An individual born with a diagnosis of a disorder or
10 difference in sex development shall have the relevant legal protections
11 and accommodations afforded under the federal Americans with Disabilities
12 Act of 1990, as amended.

13 **Sec. 8.** If any section in this act or any part of any section is
14 declared invalid or unconstitutional, the declaration shall not affect
15 the validity or constitutionality of the remaining portions.
