1 A BILL FOR AN ACT relating to appropriations; to amend Laws 2025, LB261,
2 section 245; to change appropriations to the Department of Economic
3 Development; and to repeal the original section.
4 Be it enacted by the people of the State of Nebraska,

1 **Section 1.** Laws 2025, LB261, section 245, is amended to read:

28 There is included in the amount shown as aid for FY2025-26
29 \$4,880,762 General Funds to provide aid for mentorship programs for
30 nonprofit organizations that meet eligibility requirements designed by
31 the Department of Economic Development to improve reading levels for

1 elementary students. There is included in the amount shown as aid for
2 FY2026-27 \$4,880,762 General Funds to provide aid for mentorship programs
3 for nonprofit organizations that meet eligibility requirements designed
4 by the Department of Economic Development to improve reading levels for
5 elementary students.

6 There is included in the amount shown as aid for FY2025-26
7 \$1,000,000 General Funds and for FY2026-27 \$-0- General Funds for the
8 grant authorized in section 81-1213.04, which shall only be used for such
9 purpose.

10 The unexpended Cash Fund appropriation balance for unexpended
11 obligations existing on June 30, 2025, for the Rural Workforce Housing
12 Investment Act, the Middle Income Workforce Housing Investment Act, the
13 Nebraska Affordable Housing Act, and the Nebraska Rural Projects Act, is
14 hereby reappropriated.

15 **Sec. 2.** Original Laws 2025, LB261, section 245, is repealed.
