**LEGISLATIVE BILL 922**

Introduced by Brandt, 32.

Committee: Transportation and Telecommunications

- 1 A BILL FOR AN ACT relating to the Motor Vehicle Industry Regulation Act;
- 2 to amend section 60-1411.01, Reissue Revised Statutes of Nebraska;
- 3 to change certain fees; and to repeal the original section.
- 4 Be it enacted by the people of the State of Nebraska,

1           **Section 1.** Section 60-1411.01, Reissue Revised Statutes of Nebraska,  
2 is amended to read:

3           60-1411.01 (1) To pay the expenses of the administration, operation,  
4 maintenance, and enforcement of the Motor Vehicle Industry Regulation  
5 Act, the board shall collect with each application for each class of  
6 license fees not exceeding the following amounts:

7           (a) Motor vehicle dealer's license, one thousand ~~four hundred~~  
8 dollars;

9           (b) Supplemental motor vehicle dealer's license, five hundred ~~twenty~~  
10 dollars;

11           (c) Dealer's agent license, five ~~one~~ hundred dollars;

12           (d) Motor vehicle, motorcycle, or trailer manufacturer's license,  
13 one thousand five ~~six~~ hundred dollars;

14           (e) Distributor's license, one thousand five ~~six~~ hundred dollars;

15           (f) Factory representative's license, one hundred ~~twenty~~ dollars;

16           (g) Distributor representative's license, one hundred ~~twenty~~  
17 dollars;

18           (h) Finance company's license, one thousand ~~four hundred~~ dollars;

19           (i) Wrecker or salvage dealer's license, five ~~two~~ hundred dollars;

20           (j) Factory branch license, five ~~two~~ hundred dollars;

21           (k) Motorcycle dealer's license, one thousand ~~four hundred~~ dollars;

22           (l) Motor vehicle auction dealer's license, one thousand ~~four~~  
23 ~~hundred~~ dollars; and

24           (m) Trailer dealer's license, one thousand ~~four hundred~~ dollars.

25           (2) The fees shall be fixed by the board and shall not exceed the  
26 amount actually necessary to sustain the administration, operation,  
27 maintenance, and enforcement of the act.

28           (3) Such licenses, if issued, shall expire on December 31 next  
29 following the date of the issuance thereof. Any motor vehicle,  
30 motorcycle, or trailer dealer changing its location shall not be required  
31 to obtain a new license if the new location is within the same city

1 limits or county, all requirements of law are complied with, and a fee of  
2 one hundred ~~twenty-five~~ dollars is paid, but any change of ownership of  
3 any licensee shall require a new application for a license and a new  
4 license. Change of name of licensee without change of ownership shall  
5 require the licensee to obtain a new license and pay a fee of fifty ~~five~~  
6 dollars. Applications shall be made each year for a new or renewal  
7 license. If the applicant is an individual, the application shall include  
8 the applicant's social security number.
