PRESIDENT: Ready then for the consideration of bills on select file, wow! The Chair recognizes Senator Marvel.

SENATOR MARVEL: We are having amendments typed up, I would ask unanimous consent, we passed over this bill temporarily 452. It should be up there within oh, 30 minutes.

PRESIDENT: Alright, Senator Marvel asking unanimous consent to bypass 452 for 30 minutes or so, are there any objections? Hearing none, so ordered. Would a page bring me up a work sheet please. Stand by Senator Cavanaugh. We've by passed 452, we'll begin then with 336 Senator Cavanaugh.

SENATOR CAVANAUGH: Mr. President I move that LB 336 be advanced to E&R for engrossment.

PRESIDENT: The motion is to advance LB 336, is there need for discussion of the motion on that bill? Senator Richendifer, do you have a comment or input on LB 336?

SENATOR RICHENDIFER: Mr. President on select file I would ask unanimous consent to bracket 417 for specific amendments.

PRESIDENT: 417, okay, are there objections to bracketing LB 417 for some specific amendments later, any objections? Hearing none, so ordered. The bill is bracketed then. Now the motion is to advance LB 336, is there need for discussion of the motion, all those in favor of advancing LB 336 please say aye, those opposed say no, so ordered, the bill is advanced.

SENATOR CAVANAUGH: Mr. President I move LB 336A be advanced to E&R for engrossment.

PRESIDENT: You've heard the motion now to advance LB 336A is there need for discussion? All those in favor of advancing the bill please say aye, those opposed say no, so ordered, the bill is advanced.

SENATOR CAVANAUGH: Mr. President I move the adoption of E&R amendments to LB 446.

PRESIDENT: The motion is to adopt the amendments to LB 446, all those in favor of the motion please say aye, those opposed say no, so ordered, the amendments are adopted.

SENATOR CAVANAUGH: Mr. President I move LB 446 as amended be advanced to E&R for engrossing.

PRESIDENT: The motion now is to advance LB 446, all those in favor of advancing the bill please say aye, those opposed say no, so ordered, the bill as amended is advanced.

SENATOR CAVANAUGH: Mr. President I move the adoption of E&R amendments to LB 228.

PRESIDENT: The motion now is to adopt the amendments to LB 228, all those in favor of that motion please say aye, those opposed say no. So ordered, the amendments are adopted.

SENATOR CAVANAUGH: Mr. President I move LB 228 as amended be advanced to E&R for engrossing.

PRESIDENT: You have heard the motion to advance the bill, all those in favor of advancing 228 please say aye, those opposed say no, so ordered, 228 as amended is advanced.

SENATOR CAVANAUGH: Mr. President I move LB 228A be advanced to E&R for engrossment.
