PRESIDENT: Alright, Senator Goodrich, why don't you go ahead with your motion then to kill the bill and we'll see what develops here. I have two other speakers that want to speak apparently on this motion too. Go ahead sir.

SENATOR GOODRICH: Okay, first of all we have two bills to consider here, I personally think the committee should have brought out one or the other or a combination of these bills but we didn't do it that way, so we now are faced with the possible, well with the consideration of two separate bills.
