CLERK: Alright Mr. President we have an amendment by Senator Carpenter to add the emergency clause to LB 280.

PRESIDENT: The motion is to add the emergency clause to LB 280,--

CLERK: I think Mr. President the committee amendments added the emergency clause.

SENATOR MARVEL: You want to check for sure?

CLERK: No, they did. Some amendments at least are on here, the E&R amendments have put it on, unless they got deleted somewhere, and it didn't. So the emergency clause is on it.

CLERK: It's on there, it did come on by the committee amendments, so this is unnecessary, all we need to do then is advance it.

PRESIDENT: The motion is to adopt the amendments to LB 110, all those in favor of the motion say aye, those opposed say no, so ordered, the amendments are adopted.

SENATOR CAVANAUGH: Mr. President I move LB 110 as amended be advanced to E&R for engrossing.

PRESIDENT: The motion now is to advance the bill as amended, is there need for discussion? All those in favor of advancing the bill please say aye, those opposed say no, so ordered the bill as amended is advanced.

SENATOR CAVANAUGH: Mr. President I move for the adoption of E&R amendments to LB 68A.

PRESIDENT: The motion is to adopt the amendments to LB 68A, all those in favor of that motion please say aye, those opposed, say no, the amendments are adopted.

SENATOR CAVANAUGH: Mr. President I move that LB 68A as amended be advanced to E&R for engrossing.

PRESIDENT: You have heard the motion now to advance the bill, all those in favor of advancing the bill please say aye, those opposed say no, the bill as amended is advanced.

SENATOR CAVANAUGH: Mr. President I move the adoption of E&R amendments to LB 73.

PRESIDENT: The motion is now to adopt the amendments to LB 73 all those in favor of the motion please say aye, those opposed say no, the amendments are adopted.

SENATOR CAVANAUGH: Mr. President I move that LB 73 as amended be advanced to E&R for engrossing.

PRESIDENT: The motion now is to advance the bill as amended, all those in favor of advancing the bill please say aye, those opposed say no, so ordered, the bill as amended is advanced.
