SENATOR CARPENTER: I ask that 43A be bracketed until next Wednesday.

PRESIDENT: Senator Carpenter is asking unanimous consent to bracket 43A on Select File until next Wednesday. Are there objections to bracketing the bill on Select File? Senator Carpenter, did you mean until tomorrow or a week from tomorrow.

SENATOR CARPENTER: A week from tomorrow.

PRESIDENT: Week from tomorrow. Thank you, sir. Are there objections to bracketing the bill for another week and a day? Hearing none. So ordered. 43A is bracketed. Move to 265.

PRESIDENT: Motion, now, to adopt the amendments to 319. All those in favor of that motion say aye. Those opposed say no. The amendments are adopted.

SENATOR CAVANAUGH: Mr. President, I move LB 319 as amended be advanced to E & R for engrossing.

PRESIDENT: You have heard the motion to advance the bill. All those in favor of that motion, please say aye. Those opposed say no. The bill as amended is advanced.

SENATOR CAVANAUGH: Mr. President, I move that LB 319A be advanced to E & R for engrossing.

PRESIDENT: There is a motion to advance LB 319A. All those in favor of the motion, please say aye. Those opposed say no. The bill is advanced.
