PRESIDENT: The motion to adopt the amendments to 364, all those in favor of that motion say aye, opposed say no, the amendments are adopted.

PRESIDENT: You have now heard the motion to advance the bill as amended, all those in favor of advancing the bill please say aye, those opposed say no, so ordered, the bill as amended is advanced.
