those men are all going to be new. They are not going to be effective at all, as programmed research people unless they can get out themselves, right with the committees and travel and become familiar with State facilities, and I personally would like to see this body ok, the traveling with interim study committees of these extra 9 men, if and when we get them hired, which is going pretty slow right now, but when they do get hired, lets get them familiar with State facilities so that they can be better enabled to do programmed research. Thats what we needed them for and that at least in my mind was what we hired them for. I personally feel that if we put this extra 9 men as fiscal analyst, and not as program research men, then they will be tied up by the budget committee, and nobody I'm talking to the rest of the Legislators will not get the benefit of their work. For that reason I would suggest that we keep them as program research people, working in conjunction with fiscal research, but as a separate team, and I don't care about the supervision of them, Senator Marvel, can supervise them as long as their still available this 9 program research men, are still available to the rest of the Legislature, for research.

SPEAKER: Senator Carpenter did you wish to respond?

SENATOR CARPENTERY: I'd like to have a ques, if we may, proceed in that order, out of order. Now what Senator Goodrich says is reasonably a facsimile of what I'm saying. Now first I'm not acting with the authority of the Legislative council. I'm only attempting to get a sense of direction for them without their suggesting that I do it. Now in my judgement this staff can not do 2 things. If you feel traveling with these interim study committees is the important thing, which I don't, but if you do, thats about all their going to get done. If you think they ought to be applied for the purpose in which we retain them, then you ought to leave them under the custody of Senator Marvel and his committee, because you can't go into a activity, take the University for example, or the institutions, or any activity, unless you have these men either in teams or individuals, qualified to sit down and know as much as though their trying to supervise and get the information from. If you just want to go through the purpose and the action as we generally have, thats one thing. I want this staff to go down if its necessary and sit for a week or a month or 2 months, or 6 months or a year. But when they come back to the budget committee and to this Legislature because we have access to everything they do and right fully so, we are not necessarily bound we accept what they recommend and I presume their case is wherewe won't because of reason of self evidence, but we can not do both things. Now its up to this body to make up their minds what do you want to do. Now its true, if they have not hired as rapidly as maybe we'd like to have them done, but these people are trying to be selective. Their not just hiring bodies, their trying to hire people who have some knowledge in the field in which their going to be put in order to determine and make a recomenation to the committee and to us, and we're paying these people reasonably good salaries, \$15,000-\$20,000 a year and thats the least you can get them for, and I only bring this thing to this body for your guidance and your suggestions. If you wish to follow what Senator Goodrich indicates, I have no objections, I don't agree with you, but that has nothing to do with what your going to do, but we're going to have alot of study and of many of these studies of course, some of them develope things and some of them don't, depends upon many things are not pertinent to this question. But I know from the hearing that theres going to be alot of more study, and I think this is fine. I think they ought to be referred to the standing committees, and that standing committee should be the judget and the sole judge by a majority members of that committee, whether they make the study or whether they don't and when they make that determination, that end it.
