SENATOR GOODRICH: OK. Now, first of all, Senator Chambers says that I have some devious thoughts in mind or something and that I have not lived up to a committment that I have made on this bill. I have never made any committment on this bill that I have not lived up to. I defy Senator Chambers to name one committment that was made by me that I have not lived up to on this bill. It's...I repeat, the only thing I am trying to do is to get this bill in a form that the policemen can live with if it does pass and it is for that reason that I request the bill be brought back to adopt this amendment.

PRESIDENT: The question is shall LB 315 be returned from Select File..from E & R..final E & R to Select File for specific amendment. All those in favor vote aye. All those opposed vote no. The motion is to return the bill for the amendment. Have you all voted? Once again, the chair will ask if you have all voted? All right. Senator Goodrich.

SENATOR GOODRICH: I move a Call of the House.

PRESIDENT: Senator Goodrich has asked for a Call of the House. The clerk will clear the Board. Next, Senator Goodrich has asked for a Call of the House. Will you please indicate your support of a Call of the House. All those in favor vote aye. All those opposed vote no. Senator Goodrich has asked for a Call of the House. The question under vote is the Goodrich amendment to LB 315 on Final E & R, whether it shall be returned to Select File for a specific amendment. Have you all voted? The clerk will record.

CLERK: 19 ays, 16 nays.

PRESIDENT: We are under a Call of the House. At the next bell..clear the Board..the next bell, please indicate your presence. Senator Carstens, we are under Call of the House.

CLERK: Senator Carsten voting no.

PRESIDENT: Senator Nore voting no on the original question.

CLERK: Senator Nore voting no.

PRESIDENT: Alright. That's Senator Fred Carstens for Senator Cal Carsten voting..

CLERK: Senator Cal Carsten.

PRESIDENT: Voting no on the original issue. Is that no, Senator Carsten? We are asking you to indicate your presence. We are under Call of the House. The issue under vote is the proposed motion by..the motion which would propose to return 315 to Select File for a specific amendment as outlined by Senator Goodrich. We are under Call of the House, gentlemen. Senator Skarda.

SENATOR SKARDA: To be raised.

PRESIDENT: Motion is..all right. Motion is to raise the Call. Senator Goodrich, for what purpose do you rise?

SENATOR GOODRICH: I ask for a Roll Call vote and I am not doing this lightly. The police officers of the state of Nebraska need this amendment.

PRESIDENT: Senator Goodrich has asked for a Roll Call vote. The motion relates to the return of LB 315 to Select File for a specific amendment as outlined by Senator Goodrich. The question is shall LB 315 be returned to Select File for the Goodrich specific amendment. That is the issue that you are voting upon. Senator Goodrich has asked for a roll call vote.
