SENATOR WARNER: Unanimous consent to take it up, Mr. President? Well, the purpose is to, E&R, they found another slight internal error reference to Section 7, should not have been in, should have been reference to Section 8 and then there's one place in there it has the word "board" where it should be "school board" for clarification. As I mentioned the other day, to be sure that there is no error of this nature, I'd ask unanimous consent to return the bill to select file or to take it up at this time in order that I can move it to select file for the adoption of the amendment.

PRESIDENT: Are there objections to taking up LB 472 at this time for the corrective measures, reasons as outlined by Senator Warner? Any objections? Hearing none, so ordered, then. Go ahead, Senator Warner. We'll take up--

SENATOR WARNER: Mr. President, I move that LB 472 be returned to select file for a specific amendment.

PRESIDENT: Now the motion is to return LB 472 to select file for a specific amendments which are largely corrective as the Chair understands it, in nature. Is there a need for further discussion of the motion? Question is shall 472 then be returned to select file for specific amendment? All those in favor vote aye. All those opposed vote no. Thank you. Clerk will record.

CLERK: 29 ayes, Mr. President on a motion to return.

PRESIDENT: Bill is returned. We're ready for the specific amendment. Senator Warner.

SENATOR WARNER: Mr. Pres--

CLERK: Excuse me. The specific amendment is as follows: reads amendment.

SENATOR WARNER: Now Mr. President, I move adoption of the amendment. As I pointed out, one is the, internal reference was wrong, should have been Section 8, was written Section 7. The other is the clarification of the word "board" means in this case, "school board".

PRESIDENT: Any further discussion of the amendment? Question is shall the amendment then be adopted to 472 on select file? All those in favor vote aye. All those opposed vote no. Clerk will record.

CLERK: 31 ayes, Mr. President on motion to adopt.

PRESIDENT: The amendment is adopted. Senator Warner, back to you.

SENATOR WARNER: Mr. President, I move that LB 472 be advanced to E&R for Engrossment.

PRESIDENT: Motion now is to readvance LB 472 as amended. All those in favor of readvancing the bill please say aye. Those opposed say no. So ordered, the ayes have it, the bill is readvanced. Are we ready for final reading?

CLERK: Well, we have a unanimous consent request, Mr. President, to revert to select file by Senator Burbach to take up those bills that were replaced this morning and then to consider 526, 529 and 530 and 114 in that order. Signed Senator Burbach.

PRESIDENT: Read the numbers again, please. Thank you. Senator Burbach, do you want to handle your motion here for unanimous consent to revert back to select file?
