(inaudible) matter, I doubt very much if it could be done that way.

SENATOR CARPENTER: Well first, this Body is not going to override this bill in my judgment which is besides the question, but don't you agree by the suspending of the rule, we can do anything we want to do?

SENATOR WARNER: In this case, Senator Carpenter, I'm not sure it's the rules that we would be suspending. A veto, I think, carries certain final action on the part of the Governor. I would have my doubts that you could reconsider the action having had the bill vetoed.

PRESIDENT: Senator Carpenter, the Chair would suggest that nobody knows the answer here, that you check with the Attorney General.

SENATOR CARPENTER: Well, I'm not in favor with checking with the Attorney General anything because it's just an excuse to keep people from doing or doing something. It's an old method of dodging the issue. The Attorney General's said time and time again, if he's 50% right, he's lucky. Now, I'd like to ask this Body one question. If I can develop the means by the suspension of the rules in order to put a bill on the ballot which will do substantially what apparently he's going to veto, is this Body in a mood to accept that in order to put it on a ballot and let the people determine this thing for all time to come.

PRESIDENT: Senator Goodrich and then Senator Stahmer.

SENATOR GOODRICH: Mr. President and members of the Body. There is two state aid bills, one which is Senator Snyder's bill which is still in committee, could be raised immediately. Converted to a Constitutional Amendment and processed immediately. The other one would be, I believe, Senator Duis has a bill. We could, if he would volunteer the bill, we could do it by that bill. We could end the question of whether or not we can do this. We could just procedurally do it correctly and end up with the job done with no question as to procedure.

PRESIDENT: Senator Stahmer.

SENATOR STAHMER: Senator Carpenter, Senator Carpenter, I was going to suggest the same thing to you, that you just take one of these bills. If that's supposed to be a good idea and gut it if you wanted to. Because I think otherwise you'd be having problems trying to rework a vetoed bill.

PRESIDENT: The Chair would observe we're out of the order of business here and that we could spend all morning just discussing this. I...I think we can do whatever you have the power to do. If some of you feel that you've got something real important to say, I'll recognize you. Senator Syas.

SENATOR SYAS: Well, I think it's possible. Now, I want Senator Stahmer to listen to this because in...we have two... we're going to hear Thursday two Constitutional Amendments concerning education. Neither one of them are directly germane, of course, to this proposition, because they're concerning higher education. I'm wondering though...I doubt....I'm only speaking out loud...that the Legislature would put both these Constitutional Amendments on the ballot even though they're not....they're indirectly related but not
