

**PRESIDENT:** The motion is just to return the bill Senator. I am not determining any germaness at this time. The motion is just to return the bill. I can only handle things one thing at a time. Motion is to return the bill, 254A. Senator Whitney, this is just to indicate your presence. The motion, we are under a Call of the House. Senator Duis, we are under a Call of the House, would you take your seat please. Thank you. The motion under vote is shall LB254A be returned from Select File, excuse me from Final Reading to Select File for a specific amendment? That is the motion under vote. Senator Barnett voting aye. Senator Goodrich, we are under a Call of the House. Senator Kennedy is moving that the Call be raised. All those in favor of removing the Call vote aye, all those opposed vote no. The motion is to raise the Call. Thank you, the Clerk will record.

**CLERK:** 28 ayes, 1 nay.

**PRESIDENT:** The Call is raised. Read the tally on the original vote?

**CLERK:** 18 ayes, 15 nays, correction 19 ayes Mr. President, 15 nays on the original motion.

**PRESIDENT:** Alright, the motion fails to return 254A to Select File. What other motions do we have?

**CLERK:** Now Mr. President, I move to return LB254 to Select File for a specific amendment. Signed, Senator Marsh. The specific amendment is to strike section 1 and 2 of the bill and insert as follows: "If LB1048 is enacted into law, there is hereby appropriated \$184,000 from the General Fund to the Department of Administrative Services, Program 520, State Buildings Administration. It is hereby appropriated \$50,000 from the State General Fund to the Least Office Building Fund of the Department of Administrative Services, which fund is hereby appropriated. These appropriations are to aid and carrying out the provisions of LB1048. And add a tax emergency clause.

**PRESIDENT:** The Chair recognizes Senator Marsh?

**SENATOR MARSH:** Mr. President and fellow members of this body, this is the funding necessary for LB1048. This is a germane bill because LB254A is an appropriations bill so I move that we return LB254 so that we have the funding for our State Building Administration so that we can do what this body intends to do to help construction be constructed when the money is appropriated and to follow through on the intent on this body, therefore, I move 254A be returned for this specific amendment.

**PRESIDENT:** Alright, Senator Goodrich?

**SENATOR GOODRICH:** Question of Senator Marsh, if she would yield.

**PRESIDENT:** Senator Marsh yield?

**SENATOR MARSH:** Yes certainly.

**SENATOR GOODRICH:** The traditional questions Senator Marsh, why didn't you do it in the budget committee?

**SENATOR MARSH:** Thank you Senator Goodrich. Time is what happens when we started moving the budget bills across, we had anticipated putting this in the budget bill and felt like we would like to have the budget bill moved forward so that we could have a day to override any veto which may be forthcoming. I have, on good authority, that this bill is desired by the Governor's fiscal staff, by our fiscal staff, so that I am not worried about this piece of legislation being vetoed, therefore, we can pass it on the very last day.
