opportunity to work a bill over, put some things into it that will render judges accountable and take away the public feeling that judges operate in secret and are not accountable to the public for what they do, we ought to work that bill over and put those provisions in it. Otherwise we may as well leave it the way it is now where judges are not really disciplined because under the bill that you are going to pass, if you pass it out there, and should the public adopt it, nothing will change. If a judge has prestige and disciplining him would bring the rest of the judiciary into disrepute because he is doing what others have done but a member of the public complained against him but not the rest of them, they will decide he is fit for a private reprimand and the public is left with the same feeling, that it does no good to file a complaint, there is nobody you can go to. So I am not going to support the bill in the form that it is now and I think Senator Reutzel should remember that it will take thirty and you should get the people, if they commit themselves to the bill, to be prepared to stick with it through thick and thin and not fall off if they are threatened with a veto, well I don't know if this has to be submitted to the Governor anyway, but they should not fall off for any reason. Once you have been locked in to the position the Bar Association wants you to take, you should stay there but if you are thinking about these issues, read the bill which would be the committee amendments basically and see whether or not if you were a member of the public and you read about the secret reprimands, you read about the fact that a judge can do something so bad that he or she would be suspended for six months but then allowed to come back and remain a judge. See how much regard that would give you for the system and see if you would think the bill is designed to improve the judiciary or to further protect those who are brought before this commission and if one has done something so bad that he or she must be suspended, you have given away in the Constitution for that judge to be returned to the bench and there is nothing you can say or do about it. I hope you will consider seriously what it is you are about to do but I am not going to support the bill in its present form.

SENATOR HOAGLAND: Mr. President, colleagues, I feel compelled to set the record straight after Senator Chambers' remarks and I am not really saying anything you haven't already heard before this morning but I think it is really important just to make a couple of observations. First of
