credit whatsoever available in rural Nebraska today. The fact of the matter is the Farm Credit System of this country which was established at a time during the thirties when there was no credit available is not performing the duties that they were designed to perform when they were created, to provide credit when no other credit was available. If this Legislature continues to jump through all these hoops that every business out there is wanting it to jump through so it will make it appear that there is credit when there is none available, then this Legislature can do it. My purpose is to continue to raise the issue there is no credit available, is to continue to keep the pressure on so that it's not just that poor farmer out there that can't pay his bills, not because he is a deadbeat, not because he doesn't want to pay his bills, not because he is dishonest, but simply because he doesn't have the abilities with no money. I want to continue to raise the issue and keep the pressure on so that there will be more than just that poor guy with that condition sending the message to the Farm Credit System and to the policy makers of this state and of the nation that we've got a serious problem in rural America. That's my purpose. I don't intend to vote to suspend the rules. I will not vote against it. As a matter of fact, I'm just going to let the will of this body, whatever you want to do, you can do it, but if you think you're helping that farmer out there and if you think you're helping anything long term, I think you're terribly mistaken. But I just want it a matter of record, I did not use up the ten minutes on that bill on...when it came up in its normal course of events and I had this happen to me last time and I don't remember offering such a motion. Thank you, Mr. President.

SENATOR CARSTEN: Senator Rogers.

SENATOR ROGERS: Mr. Speaker and members, I'm sorry that this all had to happen at such a late hour. Senator Landis made some comments, I guess, that I don't agree with. As far as the lien bill, my dad taught me years ago, son, when you borrow some money and sign a note you're supposed to pay it back. As far as reference to the Federal Land Bank and the PCAs, I happen to be on one of them boards. They operate just like any other business. If too many loans go bad, then I'm going to pay the extra interest. So I cannot see anything wrong with this because I think anybody, any farmer that borrows money, to my knowledge anyway, has a lien on all his property and his wife and his family. This
