

creating a credit situation to bring more people into a business where there are already too many people producing too much of the product for which there is no market, and you are telling me that is desirable.

SPEAKER NICHOL: One minute.

SENATOR CHAMBERS: Well, that is the way you all want to do it. But I think there is an aspect that cannot be escaped and that is this, because of the glut of the product and too many people in that line of work there are going to be individuals thrown out of those businesses. Since they lived on the land that they worked, they will no longer have a place to live. They will be coming around to my office, talking to me, and some of the other, perhaps, nonfarm senators who have shown a concern about people. These things are not liked. But the world is much broader than the walls of this Chamber and there is far more going on than what goes on here. There are far more concerns than those expressed in this limited, insulated cocoon where the lobbyists have sway. On that point, I read a paper, and maybe they lied, on Senator DeCamp. But he was talking about the three biggest blunders he made. He also emphasized the inordinate power that the lobbyists have over this Legislature and how they work their will in this Legislature, and I will get a copy of the article and show it to him, and he can tell me that the reporter lied on him.

SPEAKER NICHOL: Senator DeCamp is next, but may I introduce some guests in the south balcony of Senator Sieck. We have 19 members and guests of the Gresham-Reed Viewers Club from Gresham, Nebraska. Would you folks please stand and be recognized. While the Legislature is in session and capable of transacting business, I propose to sign and do sign LB 1 and LB 2. Senator DeCamp, please.

SENATOR DECAMP: Mr. President, I would like to emphasize something that I hope is corrected by next session. I think you've begun to correct it already. If I could say it, it's a fundamental or fatal flaw in the thinking of my good friend, Senator Chambers, and a lot of others, and it is this. There seems to be a tendency to view all legislation relating to farming, but mostly to finance, as being a war, I repeat, a war between the lenders and the borrowers. That is all you hear when you hear debate on whether it be credit cards, whether it be finance systems. It is a war.
