LB 194 amends the Nebraska Liquor Control Act, Nebraska Revised Statutes Section 53-112, to eliminate the salary of the commissioners of the Liquor Control Commission. The bill also provides that commissioners are not eligible to participate in the state's insurance program.

Under current law, commissioners are paid a salary of \$12,500 plus benefits. Commissioners are eligible for actual expenses under current law and would continue to be eligible to receive expense payments under LB 194.

The Nebraska Liquor Control Commission estimates that expenditures would be reduced \$81,161 for each fiscal year.

We agree with the Commission's estimate of fiscal impact.
