LB 130 pertains to state aid allocated to schools pursuant to the Tax Equity and Educational Opportunities Support Act (TEEOSA). The bill provides that school district needs as calculated in the TEEOSA formula will be adjusted proportionally, if the total amount appropriated for state aid is different than the amount necessary to fund the formula. The adjustment to calculated needs will only be made for state aid distributed in FY2011-12 and FY2012-13.

The bill has no definite fiscal impact. It may have a fiscal impact if the state aid appropriation made by the Legislature for FY12 or FY13 differs from the amount actually required to fund the TEEOSA formula, in which case, the needs and corresponding aid of individual school districts will be proportionally increased or reduced.
