This bill would redefine the term police animal.

REVIEWED BY

Current law states that a police animal means a horse or dog owned or controlled by the State of Nebraska for the purpose of assisting a Nebraska state trooper.

The bill would change this to mean a horse or dog owned or controlled by the State of Nebraska or any county, city, or village for the purpose of assisting a peace officer.

A peace officer means any officer or employee of the state or a political subdivision authorized by law to make arrests, and shall include members of the National Guard on active service by direction of the Governor during periods of emergency or civil disorder. See section 28-109.

Obstructing a peace officer, which includes a police animal assisting a peace officer, is a Class I misdemeanor (Maximum — not more than one year imprisonment, or one thousand dollars fine, or both).

It appears that this bill will not have a fiscal impact on the state or political subdivisions. The Department of Correctional Services (DCS) estimates no fiscal impact to their agency.
