LB 1131 establishes an eleven member Innovation, Discovery and Entrepreneurial Act (IDEA) Task Force. The Commissioner of Education or his or her designee is the chairperson of the task force. The task force is to hold public hearings to assist in the collection and evaluation of data and testimony and is to complete a written report by December 31, 2012 detailing its recommendations, factors to be considered in the IDEA Project, and financial measures necessary for implementation. Appointed task force members are not to be reimbursed for expenses. The act terminates on June 30, 2013.

Staff support for the task force is to be provided by the State Department of Education, the Department of Economic Development and the Department of Labor. No additional expenses for staff are assumed in order to implement the bill.

It is assumed the task force will be housed in the State Department of Education (NDE) for budget purposes. NDE estimates increased general fund expenditures of up to \$1,000 in FY2012-13 for the costs of meetings and hearings and preparation of the final report.

The Department already has resources for conducting functions similar in scope to those identified for this task force, so this would further minimize any fiscal impact.
