LB 829 amends the Nebraska Liquor Control Act to create and define alcohol impact zones.

An "alcohol impact zone" is defined as a geographic area located within a city, village, or unincorporated area of a county that is adversely affected by chronic public inebriation or illegal activity associated with sales or consumption of alcoholic liquor.

The bill provides for a city council, village board, or board of county commissioners to apply to the Liquor Control Commission for the creation of an alcohol impact zone. The application is to include a description of the issue which is the basis for the request, the geographical description of the area, which is to be as narrowly defined as possible, and any other information the Commission may require. The Commission is also required to conduct a public hearing on the application before reaching a decision on the creation of an alcohol impact zone.

LB 829 gives the Liquor Control Commission the authority to place special conditions or restrictions on a licensee having an establishment or otherwise conducting business within an alcohol impact zone.

The Liquor Control Commission indicates no fiscal impact as a result of LB 829.

We find no basis to disagree with the Commission's estimate of fiscal impact.
