LB 900 requires a report to the Health and Human Services Committee of the Legislature and the Developmental Disabilities Special Investigative Committee on or before December 1, 2012 by the directors of the divisions of: Developmental Disabilities; Behavioral Health; and Medicaid and Long-Term Care of the Department of Health and Human Services (HHS). The bill requires the report to include specific information concerning the access of individuals with co-occurring conditions of an intellectual disability and mental illness to an array of appropriate services.

HHS indicates the department will need \$20,000 of general funds to hire a consultant to develop a process to prepare the report, facilitate meetings and produce the final report. As an alternative, this fiscal note assumes existing staff and resources of the department will be used to compile, research, and analyze information, prepare a plan and make recommendations required for the report. It is assumed any expenses related to the bill requirements will be minimal and can be carried out with existing resources.
