LB 1171 enacts the Nebraska Balance of Powers Act. This act creates the Committee on Nullification of Federal Laws which consists of the Speaker of the Legislature and six other members of the Legislature appointed by the Executive Board. This committee may review any and all existing federal statutes, judicial mandates, and executive orders for the purpose of determining constitutionality. Upon the committee's recommendation for nullification, the Legislature shall vote on whether to nullify the federal action within thirty legislative days after the committee's recommendation.

There would likely be additional staffing costs in order to conduct the reviews as provided for in Section 4 subsection 3 when considering the magnitude of federal statutes, .judicial mandates and executive orders. The amount would depend on the actions of the Committee.

With respect to the indirect fiscal impact of the bill there could be some cost savings if federal programs are subsequently nullified by action of the Legislature. However there could also be a negative General Fund fiscal impact if the availability of federal funds is affected by a nullification action. In either case, the impact would be determined by actions of the Committee and Legislature which cannot be projected.
