County clerks currently charge a fee of \$15 for the entire proceedings of issuing a marriage license, administering the related oaths or affirmations, and recording a marriage certificate. They also collect an additional fee of \$5 for each certified copy of a marriage record on file in the clerk's office. These fees are deposited into the county general fund. LB 1000 would increase these fees to \$30 and \$7, respectively.

Fiscal note requests were sent to a sample of counties that included Lancaster, Sarpy and Scotts Bluff. Their responses, and the estimated increase in fee revenue, are summarized as follows.

Lancaster County -

\$38,265 of additional revenue annually

Sarpy County-

\$20,277 of additional revenue annually.

Scotts Bluff County-

\$+6,500 of additional revenue annually.

In terms of the revenue impact at a statewide level, the Nebraska Association of County Officials has estimated increased revenue for all counties of \$188,715 annually for the \$15 fee increase for issuing licenses, but does not include any additional revenue from the \$2 increase in the certified copy fee in their estimate. If it is assumed that at least one certified copy will be requested for each license issued the annual increase in statewide revenue will be \$213,877.

NACO - The increased revenues are directed to the respective county General Funds. The NACO fiscal note indicates the revenue estimates for FY 2013 and FY 2014 are based on the increased fee times the 2011 number of marriage licenses issued. In fact, mathematically the \$188,715 in the note reflects the increase in the fee of \$15 times the 2010 number of marriage licenses issued. Using the 2011 number, the revenue would be \$191,550 each year for FY 2013 and FY 2014.
