COMMENTS: The Department of Correctional Services estimate of fiscal impact from the provisions of LB 379 reflects the cost of housing inmates for longer terms with the elimination of good time and corresponding potential parole implications. The agency estimates through FY 2014-15 appear reasonable. The fiscal note identifies that there will continue to be an increased cumulative effect on the agency in future years.

Explanation of Estimate:

This bill proposes changes to eligibility of furlough and reductions of sentence terms for inmates convicted of certain charges. There is no fiscal impact related to the proposed changes to furlough guidelines.

The proposed changes to sentence reductions would have major fiscal impact on NDCS. Inmates charged as a habitual criminal or convicted with Use of a Deadly Weapon to Commit a Felony or Possession of a deadly Weapon by a Prohibited Person would likely serve twice the length of time presently specified in law.

The population would increase by 8 inmates in FY14 and 33 in FY15. Using the per diem rate of FY12 at \$6,454, the fiscal impact for FY14 and FY15 is \$51,632 and \$212,982 respectively.

The proposed changes have a cumulative effect and the average daily population would increase over the next 30 years by an average of 100 inmates per year each year using the admission rate and offense patterns of FY12. For example, in 2020, NDCS would have more than 400 additional inmates. This number would increase to over 1,000 in the year 2026.

In addition to the increased per diem expenses, a substantial population increase would require additional staffing and operational costs. As of January 31, 2013, the inmate population was 145.01% of design capacity.

Of the current NDCS population the following numbers have been convicted of: Use of a Deadly Weapon – 473; Possession of a Deadly Weapon by a Prohibited Person – 182; Habitual Criminal – 2 (an additional 176 inmates have been identified as a Habitual Criminal, but with no actual charge or additional time from the courts.)
