Explanation of Estimate:

LB 353 proposes to amend the Nursing Home Administrator Practice Act as follows:

A. Changes the educational requirements to attain a license as a nursing home administrator to a bachelors degree, effective October 1, 2015. Effective October 1, 2017 changes the core educational requirements as delineated below:

- 1. resident-centered care
- 2. quality of life
- 3. human resourses
- 4. finance
- 5. environment
- 6. leadership
- 7. management

Until October 1, 2017, the applicant would meet the current educational/previous work experience requirements, which allow for an associate degree or advanced degree or nursing degree/diploma and the current core educational areas.

B. Changes the age required to reciprocate a license of a person who holds a current nursing home administrator license in another jruisdiction from age 19 to 21.
