Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 1018 would provide \$500,000 General Funds to the Nebraska Arts Council in FY16-17 to establish a grant program to support Nebraska communities for the purpose of film production and of investment by the filming company in the economic and cultural development of the host community. LB 1018 also includes legislative intent that \$250,000 General Funds be appropriated annually in years thereafter. The Nebraska Arts Council would be directed to provide an annual report to the Appropriations Committee regarding the status of the grant program.

The Nebraska Arts Council notes that because the agency does not currently have in-house expertise in the area of film industry outreach, a staff position would be required to provide outreach and grant administration services. The agency estimates that the cost to administer the program would be approximately \$50,000 General Funds annually.
