It appears reasonable that NDCS would need to make changes to their misconduct system to generate the initial notification and notice of the result of any discipline imposed. Adding a position to coordinate the notice process and gather the additional information appears high, especially since NDCS performs some of these functions currently.

Explanation of Estimate:

LB 243 requires the Department of Correctional Services (NDCS) to provide information to individuals who are assaulted by an individual housed or held in an NDCS institution. NDCS must inform the victims of an assault of all disciplinary actions taken against the person alleged to have committed the assault and the results of such discipline when final. NDCS must also notify the appropriate County Attorney of such assault.

Over the past 3 years NDCS has averaged between 220-230 documented inmate on inmate assaults and 104 staff assaults per year. Providing notice to every victim of assault within NDCS institutions would require changes to the Department's misconduct system estimated at \$34,000 to generate the initial notification and notice of the result of any discipline imposed. Providing notice to the county attorney would require a victim notification specialist to coordinate the notice process and gather the additional information necessary to provide the County Attorney with sufficient information to determine whether charges should be filed.
