LB 320 increases the dollar value for competitive formal bidding for personal property from \$25,000 to \$50,000. The threshold for informal bidding is raised from \$10,000 to \$25,000. The threshold for unrestricted open market purchases increases from \$10,000 to \$25,000.

The threshold for real property purchases would be modified to \$64,000 (10% of the current amount established in section 81-1108.43(1)(a).

The Department of Administrative Services estimates no fiscal impact. This appears to be reasonable.
