Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 23 contains the Governors recommendation for various fund transfers and Cash Reserve Fund transfers as part of his FY2016-17 budget adjustments. In total, the bill transfers \$12,973,373 to the General Fund

The following table shows by section the affected cash fund and the amount transferred to the General Fund in FY2016-17. In some cases, the section makes a specific transfer which is the authorization itself. In other cases, the statutory change simply authorizes transfers and the actual dollar transfer is subsequently made in LB22. In several sections, the language calls for the transfer of the fund balance to the General fund as of a specific date. In these cases the dollar amount shown is an estimated amount.

Section 17 provides the any amount in the Oral Health Training and Services Fund not awarded by contract prior to February 15, 2017, shall be transferred to the Cash Reserve Fund on or before June 30, 2017. There is no estimate as to how much this might be.

Section 18 reduces an existing transfer from the General Fund to Water Sustainability Fund from \$11,000,000 to \$10,560,000.
