Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 220 changes provisions of the Insured Homeowner's Protection Act. The bill provides for there to be a written notice in any written contract, repair estimate or work order prepared by a residential contractor to provide goods or services that are to be paid by a property and casualty insurance policy stating that it is a violation of the insurance laws of the state to rebate any portion of an insurance deductible as inducement to accept a proposal to repair property. The bill provides that violations may be punishable by civil or criminal penalties.

It is assumed that persons who are found to be violating the provisions of the bill will be guilty of a fraudulent insurance act and be subject to a civil penalty of up to \$5,000 for the first violation, \$10,000 for the second violation and \$15,000 for each subsequent violation. Revenue from penalties accrues to the county where the violation occurs for use by the public schools. The number of violations of the provisions of the bill are unknown, but are not projected to be significant in number.
