Explanation of Estimate:

The Nebraska Oil and Gas Conservation Commission has the possibility of meeting one day during each month of the year. LB 761 would increase the compensation paid to each of our three (3) Commissioners by an incremental amount of \$250 per meeting. Assuming that the Commission met every month with all Commissioners present, the incremental annual expenditure would be \$9,000 for each fiscal year.
