Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 975 would adopt the Redistricting Act. The bill proposes process and procedures for conducting the decennial redistricting. For the most part, the bill should have no fiscal impact from what otherwise would occur in a redistricting process. There are two provisions which are unclear as to any fiscal impact.

Section 12 provides that the Governor shall call a special session if the Legislature fails to enact legislation to provide for district boundaries. It's unknown if this would occur and in fact under current law a special session could voluntarily be called for this purpose.

Section 6 states "The committee shall distribute the federal decennial census data received from the United States Bureau of the Census and make the maps received from the director available to the public." There could be a potential cost related to the requirement for distribution of federal decennial census data but no amount can be estimated as the bill does not state who to distribute the data to.

Note that these expenses would not occur until the next redistricting process in 2021.
