This bill would prohibit restraining animals during certain disasters or weather events. A violation is a Class I misdemeanor (Maximum — not more than one year imprisonment, or one thousand dollars fine, or both; Minimum — none).

This bill could impact county jails. Misdemeanor sentences are generally served in county jails if jail time is imposed. If the impact of this bill is to increase misdemeanor sentences by more than current law, this could result in additional costs to counties.

Any fines assessed pursuant to convictions will accrue to the county where the violation occurs to be used for the support of public schools. This amount is not known at this time.

The City of Lincoln and Lincoln-Lancaster County Emergency Management estimate no fiscal impact from this bill.
