## Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 73 requires each school board in the state to display the national motto "In God We Trust" in each classroom or in another prominent place in each school building where each student can see and read it each school day. Schools may accept contributions to defray costs to implement the bill. The Attorney General is required to intervene on behalf of any school board or named party if a suit to invalidate the bill is filed in state or federal court.

The bill may result in a minimal increase in expenditures for some school districts, depending upon how districts opt to display the national motto. Expenses can be defrayed by donations, if they are available. The Attorney General indicates the requirement to intervene on the behalf of school districts, if the provisions of the bill are challenged, will have a fiscal impact for the agency. The number of interventions is unknown. The agency will not require increased staffing pursuant to the bill, but may have a minimal increase in operating expenses. It is assumed any increase in operating expenses can be handled with existing resources of the agency.
