LB 235 amends the Nebraska Liquor Control Act to allow making, transport, and delivery of alcoholic liquor by fermentation, if it is (1) not sold or offered for sale or (2) made without a permit for an exhibition, festival, or tasting competition. The liquor must be clearly identified as alcoholic liquor manufactured under an exception to the rules and regulations of the commission by signage, and the location of the manufacturer must be available on request. The bill clarifies that free or reduced admission to the exhibition, festival, or tasting competition is not considered a sale of alcoholic liquor.

The State Patrol estimates no fiscal impact of LB 235. The Nebraska Liquor Control Commission estimates no fiscal impact of LB 235. However, the Commission's response notes that there will be a cost if the Commission is required to produce and disseminate the signage required in the bill.
