Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 115 allows children of military families to enroll preliminarily in a school district if a parent presents evidence of military orders showing the family will be stationed in the state during the current or following school year. The bill also changes current law which allows children of military families residing on federal property to be admitted to any public school in any district in which the family is residing or in another district which is near or adjacent to the place where the member is stationed. LB 115 provides that children in military families residing on federal property will be considered to be residents of the district where the property is located.

It is possible the change in the bill to provide that students of military families residing on federal property are considered to be residents of the district where the property is located may result in a change in the attendance site of a few students in the future, if the students would have opted to attend school in another district. However, the State Department of Education indicates that children from military families who reside on federal property are currently likely to enroll in the school district where the federal property is located, so it is assumed the bill will have little or no impact on where children attend school in the future.
