Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 134 would have no fiscal impact on state agencies.

LB 134 would reinstate the levy authority for natural resources districts under section 2-3225 (1)(c), which allows districts located in a river basin, subbasin or reach that has been determined to be fully appropriated or designated as overappropriated, to levy a tax not to exceed three cents on each one hundred dollars of taxable valuation. All taxable property in the district would be subject to the levy. Proceeds would be used for ground water management and integrated management activities. The levy authority would be effective from FY20-21 through FY27-28.

Previously, this levy authority had been in effect through FY2017-18. Below are the natural resources districts that carried out a levy under 2-3225 (1)(c) in FY2017-18, and the amount revenue budgeted for that levy.

LB 134 would increase the potential for revenue collections in qualifying districts. Attached is a map developed by the Department of Natural Resources that indicates fully appropriated or overappropriated districts. The amount of revenue that would be collected as a result of the levy would depend upon governing board decisions.


