LB 382 would amend provisions of the Dog and Cat Purchase Protection Act. It would 1) Require that pet shops maintain records regarding the source of each animal while it is housed at the pet shop and for at least one year after the animal was purchased; 2) Prohibit pet shops from selling dogs resulting from inbreeding or linebreeding; and 3) Would prohibit a municipality from undertaking any action to circumvent the Dog and Cat Purchase Protection Act.

It is estimated that there would be no fiscal impact to state agencies as a result of LB 382. It is further estimated that the fiscal impact to political subdivisions would be minimal.
