Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would create the Coordinated Reentry Council. For administrative and budgetary purposes, the council shall be within the Nebraska Commission on Law Enforcement and Criminal Justice (Crime Commission).

The council shall consist of voting and nonvoting members as set out in the bill. The members of the council shall be reimbursed for their actual and necessary expenses, and they will meet at least three times annually.

The Coordinated Reentry Council shall terminate on December 31, 2029.

The Crime Commission estimates the cost for expenses per meeting at \$1,800. They estimate five meetings in FY20 for a cost of \$9,000, and three meetings in FY21 for a cost of \$5,400.

Explanation of Estimate: LB 286 creates the Coordinated Reentry Council (18 members) and places the Council under the Crime Commission for administrative and budgetary purposes. The Council shall meet a minimum of three times per year.

The estimated meeting costs for this Council are based on \$1,800 per meeting and five meetings in FY 19-20 and three meetings in FY 20-21. The estimated cost per meeting is based on the average cost of a Crime Commission meeting (19 members).
