LB 360 states that only the consular officer of the nation of which the employee is a citizen and whose injury results in death, can be the sole legal representative of any alien dependents that reside outside of the United States. The bill further states that, prior to final settlement, any nonresident alien dependent may file with the Workers' Compensation Court a power of attorney designating any suitable person in the state to act as attorney in fact in the proceedings before the Court. The consular or appointed person may have the exclusive right to institute proceedings for, adjust, and settle claims before the Court. The bill also requires the appointed person to furnish a bond approved by the Court, and such bond may only be discharged upon the appointed person filing with the Court, a report verifying account of all receipts and disbursements of the money.

There is no fiscal impact.
