LB 624 changes the terms of the members of the Nebraska Craft Brewery Board. The bill requires the Governor, upon the expiration of the terms of current members in 2022, to appoint two members for a one-year term, two members for a two-year term, and three members for a three-year term, with successors being appointed to three-year terms. Members can, at the Governor's discretion, be reappointed.
