LB 791 would amend sections of law relating to livestock abandonment or neglect. LB 791 would amend law to provide that individuals convicted of felony livestock abandonment or neglect also be prohibited from owning animals as defined by section 28-1008. Sentencing for individuals convicted of misdemeanor livestock abandonment or neglect could also include a prohibition to own animals as defined under section 28-1008.

There would be no direct fiscal impact to state agencies. In the event of violations, there may be costs to law enforcement agencies to seize animals illegally owned by a convicted individual. Costs relating to such seizures would vary by circumstance and cannot be estimated at this time.
