LB 823 requires cities exercising the power of eminent domain on behalf of an out-of-state third party for purposes of transmission lines for electric power to hold a special election.

The provisions of LB 823 have no fiscal impact to the state.

The City of Lincoln estimates the cost of a special election would be between \$250,000 and \$300,000. There is no basis to disagree with this estimate. Such costs are determined by the amount of space used on the ballot. The amount of space will vary from one locale to another.

Special elections under LB 823 will result in some costs for the cities involved. The amount spent will vary and cannot be determined.
