Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would change school bus stop signal arm violation provisions. It would allow a school bus driver to report with local law enforcement violators of the school bus stop arm. This bill also directs law enforcement to investigate those reports and issue a citation if the investigation proves a violation has occurred.

It is possible that this bill could result in more citations being issued for school bus stop signal arm violations, which is a Class IV misdemeanor (Maximum — no imprisonment, five hundred dollars fine; Minimum — none). Any fines assessed pursuant to convictions will accrue to the county where the violation occurs to be used for the support of public schools.

The Department of Education estimates no fiscal impact from this bill.

The Cities of Imperial and Lincoln estimate no fiscal impact from this bill.

Sarpy County estimates that there would be an additional cost, but an amount is not available. See their response attached for additional details provided by the Sarpy County Sheriff.
