LB 794 would establish the Missing Middle Housing Act. Cities of the metropolitan class, primary class, and first class would be required to amend zoning ordinances or regulations to allow for the development of middle housing and duplexes in areas zoned for residential use that allows for the development of detached single-family housing. LB 794 specifies that such actions be undertaken on or before January 1, 2022. It is estimated that there may be some minor costs to cities to update zoning regulations, but such costs could be carried out by existing staff.
