LB937 provides the Clerk of the Legislature is to cause to be displayed within the Norris Legislative Chamber flags representing the four federally recognized tribes with headquarters in Nebraska. The bill also directs the State Capitol administrator to cause to be displayed in the Memorial Chamber on the 14th floor of the Capitol the flags of any Indian tribes with historic and regional connections to Nebraska. The bill provides the Commission on Indian Affairs is to obtain such flags through donations from the tribes. Display of the flags presumably would require flag staffs and stands. If not donated along with the flags, costs to acquire staffs and stands to display the flags would apparently fall to the Legislative Council and/or the Office of the Nebraska Capitol Commission.
